Presidential Message

Dear colleagues and clinic owners:

I hope this letter finds you all doing well and surviving the difficult times we have all been living this year. The Board held an emergency meeting July 10th to address the allowance of online CCE for this year. We made the decision to convert to allow all online CCE as it became clearer after a majority of seminars were converting to webinar and cancelling the in person classes. The approval is for the current renewal but will revert to normal for next year.

The Board staff has been significantly impacted by the COVID 19 pandemic. Full time employee Amy Deavers has been out of the office since July 10th and we had another part time employee resign due to concerns regarding COVID 19 . Mrs. Bolton has been training one new full time and two new part time employees which has made for an interesting renewal period this year. The staff are addressing renewals first and then new applicants and permits as time permits. The staffing issues have effected phone coverage at this time but we hope to be back to some level of normal following this initial rush of renewals.


