Roll was called. Those attending were: Dr. Lowman – President, Dr. Burton (arrived late at 2:15) - Vice President, Dr. Keen – Secretary / Treasurer. Members – Drs. Dr. Lowman announced quorum existed and called the meeting to order at 2:03 PM.
